STATUTORY DECLARATION


HIGHWAYS ACT 1980 SECTION 31 (6)

I AVERIL HAROLD DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. The Woodland Trust, a company limited by guarantee and registered charity no. 294344, is and has been since 3 May 1995 and 2 July 1997 the owner of the land known as Crawford's Wood and Crawfords Wood ext respectively more particularly delineated on the plan accompanying this declaration and thereon edged red.
2. On the 24 September 2003 the Woodland Trust deposited with Wigan District Council, being the appropriate Council, a statutory declaration stating that no additional ways [other than those marked in the appropriate colour on the plan accompanying this declaration] had been dedicated as footpaths since the deposit of the statement 17 July 1997.
3. No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the statutory declaration referred to in 2 above [other than those footpaths marked in the appropriate colour on the plan accompanying this declaration] and at the present time the Woodland Trust has no intention of dedicating any more public rights of way over its property.

AND I MAKE this solemn declaration on the 30<sup>th</sup> day of May, 2013 conscientiously believing it to be true and by virtue of the Statutory Declarations Act 1835.


